

### 1 Active Shooter Prevention and Preparedness

Cook Inlet Housing Authority (CIHA) takes seriously the responsibility of ensuring the safety and security of employees. They do so in a myriad of ways including evacuation drills (fire alarm, earthquake) and following safety best practices as communicated by CIHA's Safety Committee. Recently, CIHA added a new safety protocol: Active Shooter Prevention and Preparedness. The rise of active shooter incidents across the country prompted CIHA's Board of Commissioners Chairman to add the training for employees. To provide the absolute best training, CIHA reached out to law enforcement, first with the Anchorage Police Department and, based on their recommendation, with the FBI.

### 2 Phoenix Housing Choice Voucher Waitlist Opening

In Sept. 2023 the City of Phoenix Housing Department opened pre-applications for its Housing Choice Voucher waitlist, receiving 43,000+ in 15 days, a 62% increase from the prior opening. The City collaborated with internal/external partners to solicit input on critical documents and design an innovative marketing plan to advertise the opening. The opening and all documents were publicized in eight languages online, television, radio, newspapers and Chase Field billboards. We designed a vigorous process to meet the needs of all applicants, accomplishing our goal of zero applicant,

## 3 Sunnyslope Manor Launches City of Phoenix Arizona's First Leak Detection Pilot Program

Through a public-private partnership, the City of Phoenix Housing Department launched the City's first Leak Detection Pilot Project at Sunnyslope Manor, an affordable senior community. This new technology identifies water leaks in real-time. Each unit is equipped with advanced sensors to combat toilet leaks, a major source of water waste. Projected to save 10-20% in water usage, this innovation saves money that will be reinvested in our properties.

#### 4 HCV Voucher Core Application

The District of Columbia Housing Authority (DCHA) worked with Allecca Consulting and The Lab @ DC, part of Mayor Muriel Bowser and the Office of the City Administrator's goal to simplify and streamline access to government services. The Lab@ DC uses scientific insights and methods to test and improve policies and provide timely, relevant, and high-quality analysis to inform the District's most important decisions. DCHA

worked with them through their Form-a-Palooza program to systemically improve all government forms.

#### **5** Tenant Legal Services Program

The County of San Diego Dept. of Housing/Community Development's Tenant Legal Services Program helps low-income individuals and families facing or at risk of eviction by offering a range of legal services such as legal assistance, housing counseling, legal clinics, education, and case management. In response to the COVID-19 pandemic, the San Diego County Board of Supervisors allocated \$10 million in American Rescue Plan Act funds to expand legal and tenant protection services as the need was expected to increase throughout San Diego County. From August 1, 2021, to December 31, 2023, the Tenant Legal Services Program served over 4,300 households by protecting their legal rights and maintaining housing stability.

#### 7 Mindful Meetings

When the COVID-19 pandemic prompted a shift toward remote and hybrid work, Housing Catalyst leadership wanted to ensure staff still experienced a common Housing Catalyst culture and had opportunities to build the emotional resilience needed to navigate these uncertain times. A select group of Housing Catalyst staff worked with a consultant to assess their challenges and opportunities. What emerged from their discussions was the Housing Catalyst Mindful Meetings Blueprint. The blueprint provides consistent meeting templates that integrate mindfulness and emotional resilience practices to foster connection, psychological safety, and trust. The blueprint was rolled out agency-wide in 2023.

### 8 Positive Credit Reporting with RentTrack

In 2022, Housing Catalyst was selected to participate in a State of Colorado pilot that aimed to help renters build credit by reporting timely rent payments to consumer reporting agencies. The pilot, implemented by the Colorado Housing and Finance Authority, used the RentTrack platform to collect and report payment data. While only one Housing Catalyst property was chosen for the pilot, the agency saw such immediate interest and improvement in credit ratings that they decided to roll out the program to all residents in 2023. More than 230 residents are now participating in the program. New enrollees had an average credit score of 575. The current average credit score for participants is 652.

### 9 PSH Partnership with Fort Collins Police Services

With nearly a decade of experience managing Permanent Supportive Housing (PSH), Housing Catalyst has learned it takes a strong network of partners to provide appropriate supportive services. Recognizing the relationships between people who have experienced chronic homelessness and emergency services personnel are often fraught, Housing Catalyst and Fort Collins Police Services have worked intentionally to build trust. Through open communication, staff/officer education, and resident events, this partnership helps Permanent Supportive Housing residents feel safe and seen, even in moments of crisis.

#### **10** Strategic Innovation

During COVID, the Pinellas County Housing Authority (PCHA) lost its Executive Director and was under the leadership of two interims. After hiring a director in 2023, PCHA embarked on a 10-month SWOT/ Strategic Innovation analysis. Key staff and leadership were identified for the team. First, the team completed a SWOT analysis of the authority. Next a more granular SWOT analysis of each department was performed using a "whole team analysis" where employees from other departments were welcomed to share insights across other departments. Challenges and opportunities were raised and part of each department's action items, making PCHA stronger as it plans for the next 5 years.

This reduces terminations for families and also implements a right to grievance the final decision of the informal hearing officer.

The PHH includes Meditation Mondays, The Phoenix Walking Trail, Workout Wednesdays, a mental health day and A Taste of Phoenix. Providing healthy options was a hit! 100% of the staff have taken a mental health day. Meditation Mondays were used 85.5% out of 100 Mondays. 100% of staff participated in the Jump Rope Challenge and staff shared workout videos. At some point, all activities in the PHH have been and continue to be used.

#### **18** Healthier Weight for Me Program



#### 28 Employee Open House and Job Fair


#### **29** Incident Management System

#### **31 New Employee Two-Day Orientations**

In 2023, Opportunity Home San Antonio significantly increased the number of full-time employees, and the environment continued to include remote and hybrid positions. Feedback from resignations revealed that newer staff did not feel adequately trained or included in the organization. This activity was developed to enhance the engagement and connectedness new employees and even temporary staff (who could become full-time employees) would have with the organization. The program innovated from a half-day orientation presented by Human Resources, to a full two days that includes presentations from departments almost all staff interact with, and a session on our organizational values.

#### 32 WiFi Expansion Project

In 2020, the Opportunity Home San Antonio Board of Commissioners approved a \$4 million budget to expand our efforts to bring digital equity to our residents. The allocation was used to install Wi-Fi throughout all public housing and mixed-income communities to provide an enhanced service that will allow residents to excel in their communities. The project was implemented over 3 years with many obstacles and challenges, from a worldwide pandemic, a historic winter storm, supply issues, and COVID-19 staff illness. To date, we have connected all 74 communities with public Wi-Fi, giving 24,276 residents the ability to access no-cost internet in any part of their community with any device.

#### 34 Deferred Maintenance Dashboard

In response to the Covid-19 crisis, the Seattle Housing Authority (SHA) implemented a 15-month pause on performing routine, in-unit maintenance repairs to reduce the exposure and spread of the virus, creating a significant backlog of routine, in-unit repairs. To effectively address that backlog, SHA created an interactive dashboard documenting all work orders older than six months to be used to prioritize work orders and dispatch specialized maintenance teams to complete repairs. Since its implementation, the dashboard has helped significantly reduced the backlog and more than doubled the efficiency of traditional maintenance, improving the well-being and safety of residents and clients.






#### 55 The Residences at North Hill





The Housing Authority of the City of LaGrange closed its second Rental Assistance Demonstration (RAD) deal, losing 70 residents, \$110,000 in rent and \$125,215 in HUD subsidy to gain 76 newly constructed units. The housing authority needed to remain sustainable and continue revitalization efforts. The staff created an affordable rent platform that garnered \$325,000 annually. Addressing food insecurity, Greater Dayton Premiere Management (GDPM) partnered on two initiatives to bring healthy food to areas abandoned by retail grocery. ### 71 Harry's House Cultivates Togetherness in New LIHTC Housing for Seniors

Humans are social creatures, so community matters. Housing Authority of the County of Santa Barbara's Harry's House is a community platform with 59 compact tenant apartments for fully and less-ambulatory seniors of modest means within a redefined, expanded family. The two-story, farm-style architecture and yard help keep residents independent of costly, often demoralizing skilled nursing centers through a place to engage with neighbors and staff and enjoy nature. While units offer the solitude of a sleeping area, balcony, and kitchenette, they're nobody's sole universe. A sensation of home comes from a large common space, commercial kitchen, dining room, and gardens where people form friendships as the basis of a thriving support network.


### **72** Redesigned Trash Enclosures Prevent Illicit Activity, Graffiti and Transient Use

Central Plaza is a recently renovated, two-story development on 4.86 acres in Santa Maria, CA. Its 112 units range from one to three bedrooms. In 2023, the Housing Authority of the County of Santa Barbara replaced Central Plaza's dumpster containers with five enclosures that reduce trespassing, offer ADA accessibility, and look appealing. The dumpster enclosures with block walls and a screen eliminated nightly

disturbances, transients camping out and using the compounds as open-air restrooms, and drug-related crime. Special materials prevent graffiti and fob access assure resident safety and stops vandalism. Residents now use the dumpsters without fear for their health and safety.




#### 73 Nickerson Gardens Mini Park

#### 74 Westview Village II

Westview Village II is a 50-unit affordable multifamily housing development on a two-acre site in the City of Ventura. 


#### **76** Garden View Apartments

### 77 Encore Infrastructure Project Design

ENCORE is a partnership between the Bank of America Community Development Corporation and the Tampa Housing Authority. ENCORE is 40-acre mixed-use, mixed-income redevelopment community within Downtown Tampa's urban core, and one of the first master-planned developments in the state with LEED Neighborhood Development certification to promote environmentally responsible development and a whole-building approach to sustainability. #### **79** Family Housing Expansion Project

The Family Housing Expansion Project is the first of its kind in the public housing sector, bringing "missing middle," deeply affordable housing through modular construction. The project brings 26 two- and 58 three-bedroom units in fourplexes and sixplexes across 16 sites throughout Minneapolis. All units are available to households at or below 30% of the Area Median Income. Sixteen of the units will be disability accessible, with another 17 being high-priority homeless units with services through the county. Minneapolis Public Housing Authority—the developer, owner and property manager of the project—estimates these 84 new homes will serve approximately 420 families over the next 30 years.




#### **80** Wade Park Tower Renovation

# 93 Emergency Housing Voucher Program and Emergency Solutions Grant Partnership

The Housing Authority of the County of San Bernardino (HACSB) received 455 Emergency Housing Vouchers

(EHVs) from the U.S. Department of Housing and Urban Development (HUD) in 2021. The EHV allocation included a services fee of \$3,500 per allocated voucher for landlord incentives, housing navigation, and financial assistance. To adequately address housing barriers in a tight housing market, the supportive services needed to be robust. However, the supportive services were anticipated to cost more than three times the EHV services fee. To meet the need, HACSB and San Bernardino County partnered to utilize the County's Emergency Solutions Grant (ESG-CV) to supplement the EHV services fee.

#### 95 Affordable Connectivity Program Outreach

According to Bell Policy Center, owning a home is the primary path to wealth building. That works for the 65% of Coloradans who own homes, but what about renters? In Sept. 2023, Archway Communities launched the Renter Wealth Creation Fund in partnership with Enterprise Community Partners and New York Life Foundation. This innovative program provides cash back, resident services, and builds pride. Renters at Sheridan Ridge and Willow Green build wealth through on-time rent payments. In the first month, 118 residents signed up and received \$2,773 cashback total. In month two, residents received \$1,725. The early success of the program is proof Coloradans need more pathways to build wealth.




#### 129 Eviction Intervention through Mediation

#### **174** Deferred Maintenance Team

In response to the COVID-19 crisis, the Seattle Housing Authority (SHA) implemented a 15-month pause on performing routine, in-unit maintenance repairs to reduce the exposure and spread of COVID-19, creating a significant backlog of routine, in-unit repairs. To address that backlog, SHA invested in two Deferred

Maintenance Teams (DMT) that would strategically work, uninterrupted, in geographic blocks to resolve deferred work orders and observed health and safety items. Since their implementation, the DMT has significantly reduced the backlog and more than doubled the efficiency of traditional maintenance, improving the well-being and safety of residents and clients.

Recognizing the crucial role housing plays towards this end, King County Housing Authority partnered up with Highline College (HC) to design and implement the While In-School Housing Program (WISH) in 2020. WISH provides 50 time-limited (up to 54 months) housing choice vouchers to students experiencing homelessness as they further their academic goals to create a platform for long-term economic opportunity and housing stability.
